### **The Day of Atonement**

#### **The Last Fast**

I am writing to the world now. This letter is my heart for the moment and my resolution with you. I am breaking a 100 day word fast in order to sound out this resolution and make it public. Our story at Strong City is pretty well known, albeit greatly distorted by the media and the rumor mill, but I write to bring the final resolution to my own heart. What the world thinks or imagines is not especially meaningful to me, for I know that almost everything the earth has in it, is mostly fantasy and make-believe, mixed with a good bit of political force and hypocrisy. I have been leaving the earth emotionally and spiritually for many years, and others with me have been leaving it also, because of its natural hatred for what is true.

Our last event with the State occurred on October 7. Tomàs Benavidez, Deputy District Attorney, whom Donald Gallegos passed off my case to, has exhibited the classic stance of the beast. A trial was scheduled for me on October 20, 2008, but there was trouble on planet earth. All of us had agreed to be there on that day, but the evil Benavidez was having obvious and increasing difficulties with his witnesses who had not accused me of any sexual activity with them. He could not trust them in court for they do not sup-



port his imaginary theories. His lying assumption was that I had "sex with kids." He used the term, "sexual touching." He even uttered the words "sexual penetration" two times at the hearing, revealing where his mind is on the matter, clearly mixing in descriptive terms that had nothing whatever to do with this trial. He is going all out to try to insure that everyone believes the concoction that he has made up out of his own mind in regard to me. So on the 7th of October he asked for a month's extension, putting the trial off for another month while he scurries around trying to find some "educated" false witnesses to invent from their professional opinion that the two minor witnesses really are victims but they are just too young and stupid to know it.

But there is one very galling incident that absolutely made it hard to keep from losing my lunch. The man had the astonishing brashness to offer me a plea bargain that if I would confess to one of his lies, then he would not bring up two other lies that he had manufactured. If I had actually molested girls then why would he forget two molestations and leave those girls without vindication? The man is a liar, and it is he who should confess. Now Benavidez is trying to find some psychologists he can use to try and prove that his witnesses cannot be trusted because they have been hypnotized in some way by this mysterious cult leader, namely me. He has been working on this case for five months and now he wants to extend the trial date so he can find someone to prove his own witnesses are mentally unfit, and that he actually knows the real truth about me and what happened here, though we have never spoken personally and he knows nothing about Strong City at all. He said in our hearing that the young people really are victims even though they say that they are not victims and that I never touched them sexually. He claims that they are unqualified to know that. It is Benavidez who is entirely unqualified to know anything of a rational nature. He is delaying because he knows he doesn't have a case, and no witnesses, and it is the responsibility of the DA to have a case. He is delaying the trial because the State is trying to get some witness experts to molest Healed's mind. These child molesters ought to get "life" for this, and they will.

At the hearing, Sarah Montoya made a motion that the court cease and desist using the term "alleged victims" for the girls that the State is trying to use to convict me of a crime, because the girls are not complaining that they are victims, but have plainly stated on tape and in the "safe room" interviews that I did not molest them. The deputy DA was highly indignant at this exposure, and expressed his disapproval of the girls being seen as "pawns of the State." In reality, "pawns of the State" are exactly what these young people are. They are being molested by the State, and the State is soon to receive its just reward. I pray for it daily and I know it will come.



The evil court clerk, Karen Vieites, spooks around spreading her rumors and gossip, calling up the elementary school which is across the street from the courthouse to tell them I am coming to court so they should hide all of the kids, or I might run right over and molest them all, and also dishing out the lie that it was "Wayne Bent's attorney" who asked for the extension of the trial date, rather than the deputy DA. By saying that I asked for an extension, it insinuated that I was running and needed time to get my "act" together. It is the deputy DA who is running, and he needed more time because his case is a fraud. The court never gave me instructions to stay away from any school, anywhere. Vieites is a ghost and she floats, exhibiting any image that she chooses, without any basis in fact.

The State has a vendetta, and they will tell any lie and do any dastardly deed to try and prove its own hysterical images and that its lie is the truth. Tomàs Benavidez, Deputy District Attorney, has proven himself a criminal and a liar. If he is not a liar, but really believes the story he has made up in his head, he is mentally unfit for his job and he would do better to get real work like sweeping streets, instead of continually trying to make young people out as unqualified to make rational judgments. If his two witnesses testified just what he wanted to hear, you could count on the fact that he would think that they were very qualified. It is because they don't give witness to his picture that he declares them mentally unqualified. I read his motions myself, and I circled all the lies that were written there. I circled the things he knows very well did not happen, from the mouth of his own witnesses.

This scenario would be analogous to the State arresting a man for robbing a bank. The man testifies that he did not rob a bank and the bank testifies that it was not robbed, but the State has a gigantic interest in showing that a bank was robbed, so it continues to charge the man with bank robbery. The State then hires professional psychiatrists and forensic experts to give testimony that the bank could not possibly know if it was robbed or not, because the bank had only been in that location for 16 years. Suddenly, it all makes sense to the jury. Yes, they think, how would the bank know if it had been robbed, since it was only 16 years old?

Healed, who is one of the witnesses, has stated emphatically again and again that she will not lie for the DA and say that she was my victim when she was not. She wants to come home to Strong City where her grandmother, aunt, and true family reside, but the court has banned her from coming to Strong City or having any contact with her family and friends in this land. My attorney, Sarah Montoya, appealed to Judge Baca to appoint an attorney for Healed, since by the action of the State she was being denied



her first amendment rights to freedom of religion, which is what the real issue is in her case, and she needed someone to represent her. Sarah presented to the judge that the reason for this request was because Healed isn't being heard; no one is listening to her so she has had no voice in the court proceedings; she is being lied about and no one is listening to her honest testimony. She is unhappy where she is and doesn't agree with or participate in her parents' life style; she is being held where she doesn't want to be, and where no one hears her. The judge consulted his own self-interests and refused. Healed would stay in custody against her will at her parents' house. She is a 17-year-old woman, but the state keeps her imprisoned and will not give her representation. She is being held as a hostage "witness" by the State. When the judge fell into the net of the deputy DA, refusing to help Healed, even under direct appeal, he lost his credibility with me. The court became contemptible. He willingly played into the deputy DA's deception that Healed needed a psychiatrist to prove that she was incompetent because she would not lie for him and testify against me.

Some souls may believe now that I am just protecting my own self-interests, since everyone has a point of view. But this is not the case. I have no self-interests at all. But I am not an idiot and I can see right from wrong, no matter who is being accosted. When President Bush and the American people went into Iraq on a lie and murdered a million men, women and children, raping, torturing and pillaging as they went, I could see it and protest. It had nothing to do with self-interests. Human self-interests would have said, "Oh good, we get their oil, kill them all." I care about people and I have had to put away my self-interests to do that. I will not tolerate the abuse of Healed because the abuse is criminal, and not because I have something to gain by defending her human rights. Doesn't America feign concern for human rights? I am holding Americans to it. America's hypocritical self-righteousness is being exposed for the diabolical fraud that it is.

Anyone with only a small amount of common sense and reasonableness would be utterly impressed with Healed's videotaped testimony from her "safe" room interview. She is far more educated and lucid than the deputy DA. She was far more expressive and utterly fair than her CYFD interrogators. It was a wonder to behold. Her overage interrogators seemed almost in a demonic, hypnotic trance when questioning her. They reminded me of poisonous serpents deceiving their way into the young ladies' consciousness to try and find a trap for me out of anything that the witnesses might be induced to say. Healed's clear eyes and sweet countenance and pure, honest expression made the deputy DA look in comparison like a dumb dog rolling around in his excrement. Because she is so clear and lucid the deputy DA must find some "official source" to state that her utter brilliance and bright



mind is only a trick of the mind hypnotized into her by her cult leader. He is trying to make her utter clarity look like a deception, while it is his utter dementia that is so obvious to us. Of course this was all concealed beneath the constant flow of lies that poured out of the deputy DA's mouth like a river turned to blood. His physical appearance is like a man with a hangover.

But now I will tolerate this utter deception and molestation of rational thinking no more. If they ran the courts in an honest, factual way, I could cooperate. But now they have exposed themselves as running on pretense, traps and lies. This "witch hunt" so aptly put by one attorney not involved in the case, is precisely what it is. I have watched my attorney invest large amounts of her own time and money to make very strong appeals for justice, only to have most of her efforts swept aside in a cloud of smoke, while the deputy DA need only belch, and the judge gives into his flatulence and other foul gas. When we listened to the deputy DA drool off his utter nonsense and mystical froth, we could hardly comprehend that any sane, conscious person would not just break down in utter hysterics, but the judge seemed to actually take him seriously. He actually seemed to regard this man as credible in some of the utter nonsense that he spouted. His fantasy land was deemed credible. But, such is the nature of fallen man. He believes his stuff because it is the stuff of his own nature. If the DA were a woman, and the judge a woman, I think I could expect more reasonableness, but men can only judge by their own lustful frothing.

Today, October 9, is the Day of Atonement. On this day there is a traditional fast where neither food nor water is taken. I am keeping this fast today, and then immediately entering into another fast. I am entering into the deliverance promised in the Scriptures for this day we are in. "In that day," is how the Scriptures put it. I am entering into the "change." I am doing this because I will no longer tolerate the State and Healed's offended parents, to use me as an excuse to keep Healed enslaved and enmeshed in their miserable and Godless lives; nor will I allow them to use me as an excuse to punish Healed any longer. The first seven days of the fast I will cut my intake of food to one meal a day. The second seven days I will take only juice. The third seven days of the fast, I will take only water. After October 31st, if I am still on earth, I will take neither food nor water, and I will not eat or drink again until I eat and drink anew with those whom Father has given me, in my Father's kingdom. At the first coming of Messiah, Jesus made the same statement, "I am all done eating and drinking," at the end of his mission. He told his disciples, "I say to you, I will not drink henceforth of this fruit of the vine, until that day when I drink it new with you in my Father's kingdom." Matthew 26:29. So it is again at the second coming of Messiah.



I am taking this course because I have come to the clear realization that the State cannot honestly comprehend us, so there is no purpose for me to speak with the court in regard to these things. I think that by November 17, when the trial is scheduled, there will be no Wayne Bent to try. November certainly is not in the present instructions that my Father is giving me. I am not the State's thing, I am God's thing, and it would do the State well to come to grips with this reality. I will not be used for the beast's despicable agenda against our church. I am all through playing ball with the beast, so I will not throw the ball back to the beast any more. In order for the game to go on, I would have to play, and I will no longer play with proven liars and obvious deceivers who break all of the rules of honest jurisprudence.

October 31, 2008 is the end of our mission here. From October 31, 2000 to October 31, 2007, we fulfilled the seven year covenant which is written in Daniel 9 describing the events and the people of the Prince who was to come; and we are now at the end of the fulfillment of the time of "the last trump," the year of the jubilee, the last jubilee this world will ever see. The Father in heaven asked us at the end of the seven year covenant to "Stay with Me one more year." It was the year of jubilee, and this we have done. Our Father in heaven marked the beginning of our seven year covenant in 2000 by twenty-one days, and now at the end of the jubilee year He is marking it by twenty-one days. We have kept our covenant with Him and now He will keep His covenant with us and bring the promised deliverance and change.

I know beyond the shadow of a doubt that my heavenly Father put this fast for the change upon me, and I have not one fear of any consequences. I have no concern about what will happen, because God gave this fast to me. I was awakened just before midnight and for four hours He laid out His instructions to me. It is my Father's total responsibility what He does with this, because He is the One Who put it on me. He WILL bring the results from it that He desires, just as He has brought the results He has wanted from every other fast He has put upon me.

### **Suicide?**

At this point in time, someone will say, "You are going to commit suicide!" Why should I, or we, commit suicide? I am not humiliated, afraid, embarrassed, or worried about anything. The media has consistently trumpeted their feigned "fear" of suicide, when there is nothing that they would love more than that. The beast would delight in our demise, for it would only prove its present lying wonder. Sorry, no such luck for you. Our city happens to love looking the beast square in the eyes, until its lying carcass is



thrown into the lake of fire. There will be no suicide. Neither will there be any physical resistance by us. We will give you no excuse as did the Branch Davidians. You torched them, destroying all of their children in the flames right at the time you were feigning concern for the "kids." No, we will not raise one single stick in physical resistance to the beast and therefore we will give the beast no excuse. Neither will we play its diabolical game anymore.

If the beast brought out to our land a hundred tanks, and 10,000 men all heavily armed, all I would get is a warm fuzzy feeling inside. I love "playing army." When boys grow up their toys get more expensive and they hurt more people with them, but they are still boys. I used to like it when I was a small child also. I would get my little plastic tanks and cars and make sounds like, "Vroom, Vroom" as I drove them around my little sandbox. When I see the armies of man arrayed against me, I am delighted and blessed, because I am waiting to see what God is going to do with them. When the police came for me the first time, I saw how much they enjoyed playing like I was a dangerous cult leader. They really took themselves very seriously. But they can do nothing to me except what is given them from above, and whatever the Father gives them is okay with me. I am not mad at them, or afraid. I am not mad at any of my enemies, nor do I have any reason to run from them. They can only do what my Father gives them to do, for in the end it only exposes them anyway. It is all well with me and the rest of our souls here.

None of my other "enemies" bother me either. I love them and I understand them. God has shown me how they feel. I feel sorry for the parents who have had some "cult leader" win the hearts of their youth. I know just how they feel. From their point of view, I agree with their efforts to try and keep their children away from Strong City, because they themselves are no longer here. The parents want their children to come to their own cult, and not follow mine. I know how it feels to be without God and only making decisions out of one's own self interests. When Christ has left the heart, a soul can only be out for himself; he cannot care about the heart of someone else, especially his children. I know all about this. I understand the hatred of those who have not had Christ appear in them. It is reasonable for them to see things from their flesh. I can understand why they can't stand to admit that Christ Himself has appeared in Healed and is presently living in her, just as He lives in me, because it is more comfortable to their flesh for these apostate parents to believe that their children were simply victims of my "mind control" and if they can just keep them separated from us long enough, they will finally become "normal" once again like they are.



I understand why the DA and the deputy DA feel free to lie, and get all kinds of experts to testify that all cult leaders do this or that. Actually, there is no cult on the face of the earth more dangerous than the American cult. That cult forces, tortures, brainwashes and hypnotizes more people than any other religious faction on earth. They come against me not for "sex crimes" but only because the beast sees me as a threat and in competition with it. But the people cannot understand that I am not as one of their own cult leaders. They can only put their spin on me and assume I am like their images of other human leaders. I understand them. I understand why they would lie, because they believe that under these circumstances, lying is okay. "It is for a good cause." Before Christ appeared in me, I would have been just like these people, except that I would have been worse than they.

If I were as other men, and if we were like your "cults," truly we would have all committed suicide by now. Or, at least, I would have gotten into my car and fled the police and run off to Utah, or some other place, trying to save myself. But I am not like you, and I am not like other men, for Christ has appeared in me. It is the beast that cannot understand me. The beast has no basis on which to understand me or judge me, for without God he only has his own fears, torments and suspicions from which to judge me. He only has himself to view me by. Since he is so utterly dangerous and manipulative, he views me that way. My Father sent me to bring His judgment to the earth and to take His children home. I am not mistaken at how I judge the beast and those with its mark, because my Father has clearly opened up these things in vision. He tells me all about you. He shows me every aspect of your reasoning and spirit. I know what is in man. He made me the "sign of the Son of Man," that all the tribes of the earth mourn over. It was prophesied, and it came to pass right on time. I only do those things that my Father tells me and I only do what pleases Him. This makes the beast livid, but I have overcome the beast. I have no concern for what the beast says or does against me. The beast would be utterly embarrassed if it only knew how little I care about its authority.

The State has had its opportunity to know the truth, for I have clearly stated it many times and in great detail. Now I will make no effort to give the beast any more light, for light cannot help blind men, for the State has shown by its actions that it has received the 5th plague where darkness covers the seat (court) of the beast. "And the fifth angel poured out his vial upon the seat of the beast; and his kingdom was full of darkness; and they gnawed their tongues for great trouble." Its day of judgment has come and he is as blind as the dead. I saw the deputy DA gnaw his tongue in great trouble because of his darkened mind. You could have been honest, but now honesty



will not help you. You insisted on the lie, and now you will get a full taste of it yourself. We are done, and it is done.

### The Answered Prayer

The present economic disaster only reflects a nation of dishonest, greedy and ignorant people. Those who love the world have no love for God in them and that means there is no love for honesty and decency, either. Their natural hypocrisy and false accusations against God's people are well known to us, for we have felt them.

On September 10, 2001, God gave me a prophecy in regard to the World Trade Center. He had me write these words:

You have gone far enough, and now I will show you who it is that rules in the heavens. You have built your Babylonish tower, but I will make the top to break off and its foundations to sink into the mire. You will see the stability of the sand you have built on. **You will try everything to save it but it will not be saved.**

This prophecy was given during the time when the first persecution of our church was beginning. God was also marking the beginning of the end of the empire by this prophecy. Last October the earth came against us with great lies and wonders and it was at that time when God came against the beast, because the beast had come against Him while He was dwelling in Wayne Bent. It is also notable that the stock market dropped most precipi-





tously over the year during the times we were actually being attacked. But now the beast would not be getting a mere symbol as with the "Twin Towers," but a literal, actual and factual collapse of its spurious money system. Instead you attacked the messenger.

We are leaving the world because it no longer permits us freedom to follow our heavenly Father's instructions to us, or to speak freely, without some form of attack against our lives. This world has taught us well that it is not friendly to God. While it has not been able to dim our love for God and each other, it has done a masterful job of erasing the last of our affections for this natural life and the earth that supports it. The world naturally hates God and we are not inclined in any way or to any degree to go the way of the beast or to receive its mark. Most souls would contend with me and say that they really do not hate God. They would say that they love God. But I mean, *really*; I don't mean "pretend" love God. A person who loves God does not love the world or even his own life. The person who loves God never lies, even a little "white lie." A person who loves God would never support armies going into a foreign country to kill people there because he does not like them, or because he does not like the leader of that country, or because that country began using Euros instead of dollars. A person who loves God does not seek his own self-interests above the needs of others. That person never loses his temper or becomes impatient. He always follows God's instructions to his heart. That is what I mean by "love."



## Who Do You Say That I Am?

I know how I look to you. "Who does this man think that he is? He calls himself 'Messiah' and demands that people listen to him. Then he is accused of sex crimes. What a jerk!" Yes, I well know these unfounded illusory accusations and hateful attitudes against me, but I have only told the truth as the Father gave it to me. Of myself, I am just a dog like the rest of you. My humanity barks away as yours does. I have nothing, whatever, to boast of. I am the same sinner you all are. But God came into me and I only live by Him now, and not by my humanity in any way or to any degree. I have a human body that I have fed and washed and clothed, but God is the Life inside of this human form, and He commanded me to tell you the truth, and follow His instructions given to me in this land, so I did. even though we testify of God's leading in our lives, and have proved that leading by these present events in our land, openly publishing everything on the Internet. The State is the Godless beast who would not know God if it had the opportunity to see Him face to face. God has commanded everything that has occurred in Strong City over our years here and we have made it all public knowledge. It must enforce its dictates with its armies and armed men in order to keep its citizens from stepping out of line one little degree from the agenda of the beast and those



with its mark. The beast wants to keep its slaves sick and dependent. The armies of the beast came for me, and showed great threatening force, while I was no threat at all to them, except, perhaps, intellectually. Modern man is not taught to think, but only feel and parrot. They seem to have no power to reason, so my reasoning absolutely dislodges their mental security. My children have more reasoning power in their little finger than the beast has in a whole city. This makes the beast furious against us because it ends up looking so ridiculous, no matter its great show. Yes, the beast can, and does, throw people in jail, but that does not mean it has any mental acumen, or that the incarceration is just. It only means it has the power of a brute animal to enforce its will by the force of arms. All they can do is go through the motions of trying to threaten us with their guns, but they don't know how to reason with us. Their investigators are worse than worthless. They know nothing about examining for the real facts so as to establish the truth. The DAs are imbecilic and the judges are empty-headed and self-interested. They know how to throw the dice, but they don't know how to count the dots on the side facing up.

The State would deny this and try to justify its extravagant farce of justice by reciting its mantra, "We just wanted to come against child abuse and sex crimes. We wanted to save the people from suicide." This was all cunningly depicted in Ben's farce of a movie. But after asking us, and having us clearly explain how they were in error, the State still came for us. But we at Strong City have only lived in the earth to serve and help. We only lived in order to assist earthlings in understanding the ways of our Heavenly Father, and to understand the nature of His healing and salvation. We lived to prepare for the next world. I came to bring the Bride of God to full salva-



tion. But because the people have given very clear evidence that they have no intention of following God, or even listening to Him, but only following their own invented gods in their made-up religions, we really have no more purpose here. There is no more reason for us to exist in a world of prisons, prejudice and inquisitions. We have decided to leave it, since we cannot live in freedom and practice our faith in God without interference. This is why we first began leaving it years ago, and then came to Strong City. Our life here has been one of teaching in the ways of our Creator, and then living from those lessons, that we might be prepared to live in the next life. We have been taught to share and have everything in common and lay down our lives for each other. But now, even in this place many miles from the nearest town, way out on a long dirt highway, we have been molested anyway. We are many miles from anywhere, seeing to our faith and life, but the beast could not ignore us any longer. Those with the mark of the beast came to mind our business and "kill" us, but they will be surprised to know that it is they who will die eternally, after the rest of us have gone on to the next dimension, the kingdom of our Father.

When I was accused by the evil district attorney, Donald Gallegos, for sex crimes, he also stated in court that I had a lot of money and that he wanted me to spend some of it for my defense. He was utterly stupid in regard to our world. Sometimes I wonder where the people in this district went to school, to vote into office a man like this. He made assertions and accusations while knowing nothing at all about who he was accusing. I own nothing, for everything I did possess at one time, I gave to the church and to the people some years ago. We all live from a common fund. Wherever there is a need, it is filled from the general fund. No one is left without. But the State knows nothing of this and nothing of us; it only knows its own selfishness and its own doctrine of "force and make-believe," as the *Protocols of Zion* so accurately foretold of it over a hundred years ago. But from their earthly point of view they cannot believe such a people actually exist on this earth. Because they lie and do not always tell the truth as we do, that's the only way



they can view us. Because of this, I could excuse their very crazy behavior here. They did not know any better. But they should know better now, for they have been told. I know the State of New Mexico has money by the way that they wasted it to come after our people; so the State can just spend some of it defending me, jailing me, and whatever else God permits them to do. The State will soon be a burned field, for God will destroy it all. This destruction has already begun. Our enemies have rejoiced over our present difficult circumstances in their drunkenness, and now in the present economic crisis, which is the effect of the beast coming against God's people, our Father commands us to rejoice over what He is now doing to them.

### **The Parents**

The irresponsible parents, who at one time abandoned their children and left us to care for them, now are still holding hostage the two remaining youth that the CYFD kidnapped from us. These negligent parents seek to kill the children's pure Spirit that flows out of them so that their own corrupt souls will not be made to feel guilty by their offspring's holy behavior. These converted children are not allowed to live by their own conscience here in a free manner. The State and the parents do not think young people should be allowed to follow God according to their conscience, so they are imprisoned in their worldly parents' homes, where there is no love and personal regard for them, or even each other. It would be acceptable to them for these young people to party around with sex and drugs on occasion, but it is not okay for them to follow the God that they have come to know and love. This is what the youth have told us themselves.

With Healed, her parents feigned fear that she might have sex with a cult leader after they were no longer members here, preferring pornography to the Spirit of Christ. If they had had a legitimate fear, why did they not bring their fears up to me when they were here? After they had left the church, they came to visit me at my house for nine hours one day. Never did they express that they were afraid that I was going to have sex with their daughter. After their visit they went home, leaving their daughter in Strong



City. They joined the cult of offended ex-members in order to try and "kill" me and to destroy the church. They wanted revenge, because Healed believed in me and she made them feel guilty. It mattered not that Healed's sister fornicated regularly with her boyfriend. They did not feign fear in regard to that. I told Healed's parents personally that they did not have to worry about their daughter, and that they were in charge of what happens to their daughter and what she does here. But their hypocrisy was clearly exposed when her underage sister had sex with her boyfriend who was not underage and the parents did nothing to stop her. She was 17 and he was 19. She can still have all of the sex she wants with whomever she likes, but Healed is not permitted to follow God according to her own conscience or even communicate with her friends in the church because of her parents' prejudice, offense, hatred and fear. She is held prisoner in her parents' home, subjected to the influence of all kinds of practices offensive to her Spirit. This gross hypocrisy is incredible to me. The time is now here when the judgments of God will be manifested. I would not have mentioned any of these hard things, but when pain is being inflicted on the innocent because of me, I must speak out.

And then to add further insult, the parents and their wicked friends have invented stories saying that several years ago I told them that I was going to have sex with seven virgins. Then the story was invented that I had stated that I had to have sex with these two underage girls. This willful dementia, and flagrant distortion of the truth, is ruthless and astonishing in its perverted and intentional grossness. These ex church members seem to have lost any semblance of honesty and truthfulness because they are offended in me, and they seem willing to do anything to retaliate for my exposure of their evil to them. The people who have come against us are not people of integrity. Those who have come against us are the offended souls who hated me because I would not pass by their fornications, adulteries and gross hypocrisies. These are the things for which they accuse me, but are guilty of themselves. Whenever they browse their pornography, they are certain that I am doing the same thing.

On August 26, 2008, our usual delivery truck went to Clayton to pick up the weekly food order for Strong City. Healed, the 17-year-old woman who is being kept in confinement by her parents, flagged down the truck and spoke with the brethren who went to town for the usual food pickup. She handed the men a paper with some Bible verses on it that expressed that she was trusting God to help her. Her mother was spying on her, so after Healed gave the men the Bible verses, her mother, Elsa Sayer, drove directly to the district attorney to tell on her and to make a claim that I was trying to contact Healed, even while I knew nothing of this encounter. The delivery truck was



not under a court order and I do not issue orders for the land or the delivery truck. They could speak with Healed all they like, since they were not part of the case and I am not their dictator.



I have kept the beast's release conditions and have not attempted contact either directly or indirectly with Healed, but her offended mother just cannot stand having her daughter, who is a 17-year-old woman, exercise any of her first amendment rights. She wants to keep her a house slave just as the State of New Mexico does.

This is the nature of your world. You are a hellhole of hypocrisy and spiritual dementia. I would not give a nickel to live with this disgusting society. Now, thanks to the false indictments of the evil State of New

Mexico, Healed must endure the lowlife environment of her parents' house which is so prevalent in this evil world today. Emotionally, she is utterly driven away from her parents, since she just cannot stand their perverted way of life. She must live in utter disgust continually because of the lowlife world that the State has thrust upon her. I believe that district attorneys who do this to young people should be given other work that will not hurt people, for they are a danger to society. They are evil, heartless and conscienceless people who do not deserve to continue their fanatical, imbecilic oppression against the noble and true hearted.

On August 29, 2008, I heard from my attorney, Sarah Montoya. This lady has donated much of her time in helping us in the legal farce introduced by the State. The State appointed her, since all of my own financial means had been given away to the church years before. She reported that the district attorney wanted to force all of Healed's friends or family in her church from having any contact with her, even though that is the only source of love she receives from human beings. The house of pornography that she is forced to live in against her will, complained because she flagged down the delivery truck to speak with some of her real family. The DA wanted to change my terms of release to include that I will require all of her church family to now shun her when they see her in town. When my terms of release only had to do with me, I agreed and complied, but now the DA has gone too far. I will not comply with such evil hearted men who are devils in human skin, or be



used by them to be a dictator over this land as they are in their own society. I will not agree to treat a young lady in this way. They may just come and throw me in prison again, but they can know in advance that I will not be eating their food or drinking their water or speaking another word to them from within their dark dungeons if ever they place me there again. The God of heaven told me personally that I need not suck the tits of the beast to insure my survival.

This is not in the realm of negotiation or preference. I would rather that my physical form die in jail than for Healed to remain imprisoned where she is, unable to follow her conscience freely and kept from being with those who love God as she does. Then there would be no trial anyway, for you cannot try a corpse, and my Spirit would be just as inaccessible to you then as it is now. And if I were falsely convicted of a crime that I did not commit, then they would not keep a corpse in jail for long. I will say this to the State: I am not your thing, your property, or your soul. Because of this act, it is I who will now make the conditions in the name of the One Who lives forever and forever: I demand that the wicked (harmful or troublesome) DA drop all of his false, made-up charges and immediately let Healed return to her real family who loves her. I demand it now. I demand that the evil state stand down, and be silent. Leave my people alone and quit molesting them, forever. I have had enough of you and your wicked, insensitive hearts. You have revealed that you have no heart and no conscience. Stop causing this precious child of God to suffer by your completely unjust terms and illegal actions. ## Prudence Welch

Prudence Welch is a woman who used to be among us pretending to love God, but who is now putting out her daily vomit and four letter words on her own Web site devoted to the destruction of the people of God. This woman is the one who started the accusations against us, and me in particular. She rides upon the back of the State with an abominable cup in her hand. She lists the sins of others on her Web site, but carefully disguises her own astonishing corruption. Prudence Welch has not been with us for years but she pretends to know everything that we do. ## The Seven Last Plagues

They have no heart for justice, fairness and love, but only a heart for their low and degraded lies and deceptions. They treat their own boy as a prisoner even though he is 16½.



The State hates the thought of him living with those he loves, but cares not if he lives with drunks and abusers. The State turns a blind eye to it, while all the time claiming to protect him from me. What a gross slap in the face to the American Constitution. They care not for one word written in it. Matthew asked his mother to buy him oranges, but she refused because of the expense. The judge excused his harsh sentence by saying that he wanted to warn others from doing what the "repentant" man had done. It all came clear as a bell after a few minutes of considering.



While a young boy, I remember reading stories about headhunters. They would kill a man and then put his head on a pole which would surround the village. It was to help protect the village from intruders and evil spirits. I read this morning about four Hindu men who raped a Catholic nun in their area. They were afraid that the Christian lady would harm their beliefs. There is a common denominator in all of this. It is fear. The day I was being taken from the land by the police, one officer said that it is okay to lie if your motive was to protect children. It is okay to lie if you are afraid.

My son and I have often wondered why this trial is going on, when no crime has been committed and there are no witnesses saying I molested them. It is because they are afraid and full of the dark spirits of suspicion, just as were the headhunters. In one of the last meetings with Sarah, the DA stated something about the "Stockholm Syndrome" as a reason to keep Healed where she was. This was an obvious fear tactic. It was a ridiculous attempt to justify the DA's false assertions. The people are bold-faced liars, but it is okay because they are afraid of me. This made all things clear to me where I had questions before. It began to make sense. I watched a video of some senators who were for the present bailout plan being considered. Every one of those shown in the video was given large sums of money by the organizations now requesting the bailout. This obvious conflict of interest did not seem to register with anyone. The



senators had a vested interest to lie in order to insure their survival. No one actually cares about the little people around them, as long as they themselves are fat and comfortable. Saul ignorantly persecuted the church but after Jesus resurrected from the dead he appeared to Saul and stopped his bloody acts once and for all, leaving him with a thorn in his flesh for the rest of his life. Then Paul was to be a constant witness for Jesus throughout the rest of his life, bringing into the church many more souls than he murdered. He was stoned, as he stoned Christians. He was killed, as he killed Christians. They killed the body of Jesus, but he returned in judgment and he set things right in a body that they could not see unless he chose to have them see him, even overseeing the complete destruction of Jerusalem who denied him in his time on earth, just as I have been denied in my time on earth by my own generation.
